IZJAVA.

Potpisani daju gosp. Haimu Montilji, zubaru iz Zagreba slijedeću izjavu. Kako je gosp. Montiljo Haim, bio od godine 1930 do 1938, glavni tajnik, najprije zubotehničkoga, zatim Dentističkog Društva, te tajnik Dentističke Komore, te ovime izjavljujemo da se je sav rad gospodina Montilje osim općih staleških interesa, koje je vodio na opći uspjeh našega staleža, bio potpunoma u saglasnosti i ciljevima opće Hrvatske orijentacije, tako da je u društvenome radu lojalno i bezprikorno uvijek zastupao Hrvatske ciljeve kako pred vlastima tako i među članstvom.

Od godine 1935 do godine 1938, vodila su Dentistička Društva sa bivšim ministarstvom Socijalne Politike i Narodnoga Zdravlja ogorčenu borbu oko donošenja Odrasbe o Dentističkim Komorama, te su naša Dentistička Društva sa tadašnjim tajnikom gospodinom Montiljom vodila ~~XXXXXXXXXX~~ borbu za posve autonomnom komorom za Hrvatske krajeve, jer Ministarstvo to nije htjelo nikako odobriti.

Kako je gospodin Montilj imao velike zasluge za dentistički stalež, i bio uvijek ispravno Hrvatski orijentiran, to mi tu izjavu dajemo ra postignuća prava, koja su njemu ispravnome građaninu potrebna.

STATEMENT.

The undersigned are making the following statement about Mr. Haim Montiljo, a dentist from Zagreb. Mr. Haim Montiljo was a chief secretary first of Dental technicians' society, and then of Dental Association from 1930 to 1938, and also secretary of the Dental Chamber; hereby we state that all Mr. Montiljo's work (apart from his professional work, which he performed proudly and professionally) has been in accordance with the goals of overall Croatian interest, and that in his socially oriented work he has always been a representative of Croatian (national) goals – in front of the authorities, and among the members.

From 1935 to 1938, Dental Association had a bitter struggle with the former Ministry of Social Politics and Public Health about the Decree on the Dental Chambers. Mr. Montiljo, as a secretary, was the leader of our Dental Association in its struggle for the foundation of an autonomous Chamber in Croatia, because the Ministry did not want to allow it.

Since Mr. Montiljo has proved to be of great importance for his entire profession, and has always had pro-Croatian political orientation, we are making this statement in order to help him acquire the rights he needs as a fair citizen.

Ovime potpisani izjavljuju da dobre poznaju gosp. dentistu Haima Montilju zubara iz Zagreba Nikolićeva ul. br. 15 II., te solidarno izjavljuju slijedeće :

Imagovani se je uvijek korektno iskazao u svima hrvatskim pothvatima te spomenuti u mnogim skicijama proti tadašnjih policijskih vlasti s nama u demonstracijama uz radi Hrvatsstva sudjelovao.

Naročito za vrijeme velikih protuhrvatskih režima i za vrijeme petosvibanjskih izbora god. 1935. - gospodin Montiljo Haim sudjelovao je s nama u borbi sa policijom u Nikolićevoj ul. br. 15 kada su se spomenutog vremena odigravale velike borbe sa policijom i četnicima. Tom prilikom mi smo potpisani u našu vežu i dvorište Nikolićeve ul. br. 15 posakrivali preko 150 hrvatskih demonstranata i iz veže se solidarno tukli sa tadašnjom policijom i četnicima. Sukobi su bili teški i takeve naravi da smo postavili u dvorištu stoleve, sanduke, kola te smo se iza njih branili od navale policije.

Nakon dvosatne borbe uspjele su da je prebiti se kroz vežu i nastaviti sa demonstracijama na ulici te je tom prilikom ~~ranjen~~ gospodin Montiljo na Jelačićevom trgu od policije uhapšen i zatvoren glasom presude tadašnje Uprave policije u Zagrebu od 24. 7. 1935. - broj : 92458 - - 1 - 1935. - , čiji prepis prilaže se ovoj izjavi, i te ovjerovljeni. - Ovu izjavu dajemo gospodinu Haimu Montilju u znak priznanja za njegov hrvatski rad, te ju vlastoručnim potpisima potvrđujemo.

The undersigned are making a statement that they are well-acquainted Mr. Haim Montiljo, a dentist from Zagreb (15 Nikolićeva Street), and in solidarity are stating this:

The person in question has always excelled in all pro-Croatian activities and he has been part of many demonstrations against police authorities.

Especially during anti-Croatian regime and the elections of 5 May 1935 – together with the rest of us, Mr. Haim Montiljo was involved in a fight with the police in 15 Nikolićeva Street during great fights with the police and chetniks. In that occasion, we, the undersigned, hid over 150 Croatian protestors in the courtyard of 15 Nikolićeva Street. The conflicts were tough and such that we put tables, chests and wheels in the courtyard in order to stop the police attacks.

After the two-hour struggle, we managed to make it through the courtyard and continue with the demonstrations on the street. This is when Mr. Montiljo was wounded on Jelačić Square and then arrested; afterwards, he sentenced to jail by the verdict number 92458 – 1 – 1935 on 24 July 1935 by the former Police Directorate of Zagreb. A certified copy of the document is attached to this statement, and this statement is given for the recognition of Mr. Montiljo's pro-Croatian activities, and confirmed by our own signatures.

Petition

I will elaborate with following arguments:

I have been raised as a Croat by my mother, whose father was elected for Zagreb City Council in 1892, as a member of opposition, during the assimilation movement, which provided many public workers from the Jewish ranks, both in cultural and political field.

All my life I have worked and acted as a Croat, and I have never been a member of any Zionist or Masonic society.

In high-school I was a member of Croatian Falcon and HAŠK (Croatian Academic Sport Club).

As a technician, I worked in Croatian ranks in Prague and in academic society *Croat* in Prague.

During World War 1914-1918 I was a soldier in Austria-Hungarian army, and I was decorated with small silver medal of courage and a military cross for merits of the 3rd class with swords (*Militär Verdienstkreuz III. Kl. mit Schwertern*), and awarded with *Karl Truppenkreuz*.

In 1923 I converted to Roman-Catholicism, and the same year I married the niece of Mrs. Marija Radić.

In that marriage a daughter was born, and her Aryan descent with belonging rights has been recognized, as she is being raised as a Croatian patriot.

From 1918 onwards I have always been among Croatian ranks and in all elections I voted only for Croatian parties, and I have never been absent from voting.

During the dictatorship I have worked actively for Croatian victims and I have donated and collected money and gifts for them, even though this could have been sanctioned with toughest punishment.

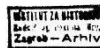

To Mr. *Poglavnik* of Independent State of Croatia I have already submitted a petition, in order to gain Aryan rights on the basis of the Article 6 of the Law Decree on Racial Affiliation.

I was born on June 15, 1895, in Karlovac, where my family comes from, and therefore I am a resident of Independent State of Croatia. I am a Greek-Catholic.

My wife Desanka (born Drobac) from Zagreb, is also a Greek-Catholic, as well as my son Momir, a student of Secondary Technical School in Zagreb.

Our daughter Gorica is married to a Croat-Catholic Milan Jug, who lives with me in the same household.

Besides other claims, those emphasized in a petition I sent to Mr. *Poglavnik*, I would like to mention, that to the earlier petition I have enclosed the following statement:

“The undersigned would like to declare that we have known Slavko Walder, a weaving craftsman from Zagreb, 8 Gajdekova Street, for a long period of time, and we know that so far he has always been a just person and that his work has always been in accordance with the interests of Croatian people, and this is why we vouch for him.

Mr. Haim Montiljo, a dentist from Zagreb, was a secretary of the *Society of Independent Dental Technicians* since the foundation of the society in 1930 till 1933. The society then changed its name to *Croatian Dental Society* and Mr. Montiljo was a secretary from 1933 to 1930, when he decided to resign.

During this period he distinguished himself with unselfishness and hard work for the benefit of the entire profession, so on 16 April 1938, the members elected him unanimously for the position of the secretary of the Dental Chamber in Zagreb, and he left this position in late 1938.

As a secretary of the Chamber, he was especially active in the struggle for the withdrawal of Croatian dentists from the centralist Chamber in Belgrade and the foundation of an independent Croatian Dental Chamber.

As a token of recognition for his great merits for the entire profession of Croatian dentists, *Croatian Dental Society* elected Mr. Haim Montiljo unanimously as an HONORARY MEMBER in 1935.

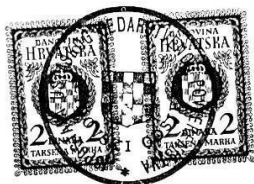

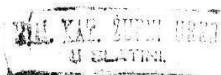

Undersigned Croatian citizens from Podravska Slatina hereby declare that it is true that a publisher and a paper mill owner in Slatina, Ljudevit Bauer, who died in 1939, was considered to be (during his 40-year-long stay in Slatina) to be a determined, unshakable Croat (on behalf of other citizens). As such, he was persecuted, and his business suffered a lot; also, anti-Croatian government placed him in house arrest.

Deceased Ljudevit Bauer was a part of every Croatian national movement (together with Croats from Podravska Slatina), and as a true Croat, in every municipal or parliamentary election he voted for the Croatian candidates.

He died in materially bad conditions, and his wife, who is severely ill (she suffered a stroke for a couple of times) and weak, has been accommodated to the Monastery of the Sisters of Mercy in Slatina where they take care of her. It was organized by the Croats-Catholics of Podravska Slatina.

For all the reasons mentioned above, undersigned Croatian citizens from Slatina would like to recommend her petition sent to the Ministry of Internal Affairs of Independent State of Croatia, hoping for a positive resolution.

I was born in Karlovac on 1 August 1912. My parents were artisans who moved to Zagreb in 1913, the city I live in.

I was educated to be a dental technician at the office of a dentist called Leo Paspas (Zagreb, Masarykova Street).

I was an active member of "CROATIAN FALCON" since its closure. On the day *Doglavnik* Dr. Mile Budak was attacked, I volunteered to be among the forty members of the guard that was assembled by: Ivan Werner, Miško Zečić, Nikola Hus and other former councilors. The guard was set up around Dr. Gottlieb sanatorium on Srebrnjak, where wounded *Doglavnik* Dr. Budak was lying. I was on the watch for two nights in a row, until I was substituted.

I am mentioning this as a proof that I was ready to face all possible consequences in order to protect a member of Croatian leadership, and that I was raised to be a Croatian patriot. The truthfulness of my words is confirmed by the signatures of the undersigned gentlemen.

Since I am supporting my wife and my mother, and since, as a Jew, I am in a situation where my whole life and work are being denied, I am pleading you to take the abovementioned information into consideration, because according to the current law I have no rights, and I need them to be able to continue with my trade.

I am hoping to get a positive answer to my petition, and I hope I will be given a chance to prove, both by my behavior and my work, that I am worthy of it.

However, Adolf Švarc was a corporal in the 53rd infantry regiment in Zagreb, and he distinguished himself on 5 December 1918, in a military uprising against the Serbs in Zagreb.

He was sentenced to a prison (3 and a half years) by the verdict of a military court (indictment number 6/I 359/18).

Since Adolf Švarc proved, both during the war and the uprising, that he is an exemplary Croat, and he has distinguished himself with bravery, we are asking

The Ministry of Internal Affairs to approve and impose an order that would release mentioned Adolf Švarc from internment, and exempt him from the Anti-Jewish measures, till the law on the Jews is passed.

We believe that persecution of any kind of these people would cause a resentment among our community, and therefore this Municipality is suggesting you to make everything possible to leave these people alone, i.e. not to apply the anti-Jewish measures.

We, the undersigned, who managed to survive and who burned the Hungarian flag on Jelačić Square in Zagreb in 1895, would like to witness that Irena Hirschl, born Rosenberg, a Jew, 69 years old, born in a place Orle, raised in Koprivnica, married to Samuel Hirschl (now located in Jasenovac camp), a mother of four (residents of Koprivnica), has always been a fiery Croatian, a supporter of Ante Starčević.

As a young girl, she used to come to the house of deceased Jurica Balaško in 27 Petrinjska Street, which was a meeting place for all Starčević supporters, and where Ante Starčević, "Father of Our Homeland", used to come himself, together with his brother David and niece Mila, and where the rest of us, Starčević supporters, used to gather. Mentioned Irena Hirschl knitted with her own hands the Hungarian flag that was later burnt. Because of this, she was persecuted by the police. Later, while the rest of us were in prison, she was bringing us food and cigarettes – until we were transferred to Bjelovar. On the funeral of the Father of Our Homeland, she was carrying the wreath with Mrs. Haligonja (born Majtanić) from Zagreb. She was given a picture of a Father of Our Homeland – Ante Starčević – as a souvenir.

We found out that she has been in Lobar-grad camp for four months, very ill, so we are pleading you, *Poglavnik*, to set her and her husband, who is 71 years old, free, and grant her civil rights, because as a Croatian who supported Starčević, albeit Jewish, she deserved it.

Knowing your noble heart, dear *Poglavnik*, we are sending this petition to you, hoping you will take it into consideration.

In union with my husband Eugen Mendel, I, the undersigned, own one-story house with one apartment in Podsused n. 222, and we have acquired it through many years of joint work as private employees. On September 18, my husband was taken, as a Jew, to Jasenovac camp for no reason. Since that day, together with my one-year-old child, I have been experiencing unpleasantries almost every day. Since police sergeant Mr. Šimunić has moved in my apartment, I have been living in cramped conditions, my assets are in question every day, especially since the district authorities want to expropriate me entirely from my property.

I am therefore pleading the honorable title to conduct an investigation why my husband has been taken to the camp, and in case his innocence is proven, set him free. I am pleading it especially because my husband was an official member of Croatian Peasant Party, and he had always voted for it, and has always supported all pro-Croatian activities. I would also like to ask the high authority to conduct an investigation regarding the acquisition of the mentioned real estate (Podsused number 222). If you conclude that we have acquired it only through our honest work and sacrifice, I would like the high authority to secure me to use my asset undisturbed.

I am corroborating my petition with numerous signatures of citizens of Podsused who can testify about our stand and the fact that we have never sinned against the interests of the Croatian people.

Excepting a quick and favorable solution to this problem, I am sending my regards.

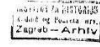

The branch office in Sarajevo sent a plea regarding freedom of movement for its member, the Jew Avram Daniti, and to the military motorized battalion for re-employment as a mechanical locksmith.

Both authorities have granted the request as shown in the attached letter.

The Sarajevo Workers' Chamber attachment below sets out the national work of the aforementioned Jew, which in Sarajevo has certainly been an exceptional occurrence that, among anational Jews we find one Avram Daniti, who had already in 1918 sided with the Croatian national movement, which for him and other nationalists led to persecutions and various harassments by the authorities, and well as boycotting within the Jewish community. The aforementioned did not allow himself to be persuaded by any and suffered all persecutions, and has remained a faithful soldier among Croatian nationalists. In siding with Croatian nationalists, Avram Daniti has been guided only by the feeling he had gained in the European war in 1914-1918, in which, as a Jew, he had been ordained with a golden and silver medal for courage; and it is well known that, during the European war, almost all Jews were "Enthoben" [T/n: relieved of their duty], or if they did serve in the army, were charged with covertly conducting espionage or sabotage.

We are unable to describe all details, but Croatian nationalists can testify that Avram Daniti led the struggle of the Croatian youth against the then infamous "Orijuna", Pribičević's avant-garde movement comprised of the worst scum imaginable, tasked with destroying all that is Croatian or that feels so. Despite the infamous Belgrade public's political machinations, the Croatian people in Sarajevo did not waver, but fought together with the entire Croatian nation – a struggle in which Avram Daniti actively participated. He was also one of the first members of the Croatian Workers' Association branch, as well as a member of the "Trebević" choir association, the Croatian "Progress" association [T/N: Napredak] and the Croatian reading society in Sarajevo.

In view of what we presented here, we are turning to you, the central committee's secretary, with a request to help us in this matter, because the aforementioned was interned in Jasenovac together with his family. During the internment of the Jews from Sarajevo to Jasenovac, the very same Avram Daniti was denounced by a few irresponsible individuals and deprived of liberty alongside his family, and transferred to the Jasenovac concentration camp. Our workers' branch feels morally obliged to stand up for its member, but is unable to take any action in Sarajevo, as is the local authorities; we thus plead with you, our dear confidante, that you would be so kind to intervene for Avram Daniti so that he could be freed from the concentration camp together with his family and returned to work in motorized battalion u Sarajevo.

This branch is addressing you personally, because you can represent this matter to relevant authorities, if it is within your good will, because your domain of work for the Ustasha leaves the possibility that you could help us in this matter

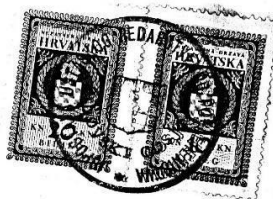

I, Dragutin Maisen, am pleading the Jewish Department of Independent State of Croatia to release my fiancée (*illegible*) (born 28 October 1919 in Novska, raised Bizovec, Valpovo, Croatia) who was arrested with her family on 9 January 1942 at 5:30 AM from her apartment in 46 Borongajska Cesta by Ustasha police, even though she has converted to Roman Catholicism. I can assure you that she is a true Croat who has never done anything against Croatian people; she is not pro-Jewish and she has never been among people who would do something contrary to Croatian interests. Therefore I am pleading the famous title to help my petition find its purpose, since I can guarantee for my fiancée and I would like to marry her.

My personal data:

Dragutin Maisen, born 1 November 1918 in Zagreb, raised in Zagreb, Roman Catholic, no criminal record, military served in Croatian Air Forces (duration 27 months) till 23 December 1941 – this is the reason why I was unable to get married sooner.

I believe you will accept these arguments and reply positively to my petition as soon as possible, before she could be taken somewhere else. I am granting for her, as well as those undersigned.

Undersigned farmers of Jastrebarsko district and its surrounding areas are pleading the Ministry of Internal Affairs of Independent State of Croatia to accept the petition made by the merchant from Jasterbarsko, Srećko Breyer. He is asking for the recognition of the Aryan and other civil rights for himself, his mother (a widow) Roza Breyer and his sister Elza (also a widow) Kuhar, born Breyer. The petition was originally sent to Mr. Poglavnik's Office and from there it was transferred to the Ministry of Internal Affairs; at that point (before the transfer) it was unsolved, but not rejected.

We are pleading you this because we are well familiar with life and history of the Breyer family, and we know that they are honest citizens and fine Croats who have always been emphasizing their Croatian sentiment; not only the three of them personally, but also the deceased Samuel Breyer (Srećko's father) who, as a fine Croat, raised his children to be loving people, full of respect for anything Croatian, and they have remained faithful to his ideas.

In our humble opinion, the Breyer family are the people who, perhaps more than anyone else, deserve to have their petition for the recognition of the Aryan and civil rights accepted.
